 - Decision: Given two proposed solutions on the issue of the legacy Community Resources content in RDA Toolkit, PoC voted to endorse the 2nd option: incorporating the content into the Metadata Guidance Documentation (MGDs).
 - Action: LC will start the process of incorporating the Community Resources documentation into the MGDs. Both PCC and LC will participate in this process.
 - **Action**: PoCo will make a decision about RDA implementation in the spring of 2023.
