Ready to create your interagency agreement (IAA) with FEDLINK? Registration is now open for Fiscal Year 2021.

To register, point your browser to the Registration Form at <http://www.loc.gov/flicc/onlinedoc/FIT/Registration.pdf>. Complete the form, save a copy for your agency records, and email the signed form to [fliccfo@loc.gov](mailto:fliccfo@loc.gov).

Within three days, FEDLINK will email your interagency agreement (IAA) and you may begin your agency's authorization process by printing out the IAA and securing the appropriate signatures from your agency. (FEDLINK may request additional supporting documentation such as Independent Government Cost Estimates (IGCEs), title lists, etc., to complete your registration.
