Definition: A work that involves a responsibility of a corporate body for creating an architectural design, including a pictorial representation intended to show how a building or other structure will look when completed.

Definition: A work that involves a legal or intellectual responsibility, but not creative responsibility, of a corporate body for the editorial policy and content of a diachronic work.
