If that 710 were not in the record, the record could be either AACR2 or RDA

The 710 makes it an AACR2 record.

The only form of name available to create the preferred name and to construct the authorized access point or heading includes the abbreviation “Dept.” This is different from the case where an AACR2 cataloger would automatically abbreviate the word “Department” if it were presented that way. Under the principle of representation, you take what you see, so this could be either RDA or AACR2.
