Cataloging Distribution Services Announcement

Cataloger's Desktop

Effective July 31, 2023, Cataloger's Desktop will no longer be available in its current configuration. This change is informed by the valuable and insightful feedback provided by Cataloger's Desktop subscribers and catalogers in a survey the Library conducted in April 2022. The ability to search Library of Congress cataloging policy documentation will be integrated into our Classification Web Plus service. The new service *Classification Web Plus*, will launch on August 1, 2023.

WHAT CHANGES:

- Cataloger's Desktop resources that will be included in Classification Web Plus are exclusively Library of Congress resources. These have been the most used resources.
- The publications and resources will be in publicly available and shareable .PDF or HTML formats
- The publications and resources will be automatically current and up-to-date

- Classification Web and Catalogers Desktop will now be available under a single subscription-Classification Web Plus
- If your Cataloger's Desktop subscription expires between May and July 2023, and you have a current *Classification Web* subscription, you will continue to have access to Cataloger's Desktop service through July 31. On Aug. 1 you will switch to using your *Classification Web Plus* subscription.
- Current Catalogers Desktop subscriptions will be converted to Classification Web Plus subscriptions on August 1, pro-rated accordingly. Current Catalogers Desktop subscriptions will continue to have access to Cataloger's Desktop service through July 31.
