Fiscal Year 2013 Accounts Are Closing

FEDLINK is sending vendors final invoices for Fiscal Year 13 with a deadline to reply set for March 2018. If you have remaining funds in these accounts, you can request expired funds (annual or multi-year funds that expired in FY 2013) be refunded to your agency by sending an email to fliccffe@loc.gov. FEDLINK will send all other expired funds back to the U.S. Treasury.

If you have multi-year funds in those accounts that have yet to expire, you may move those funds into the current year or request a refund for your agency. For assistance with moving and refunding funds, please contact your Member Services Accounting Specialist.
